AFFH-T is a public-facing application. There are no user classes, profiles, or access restrictions such that all users have the same functional permissions.

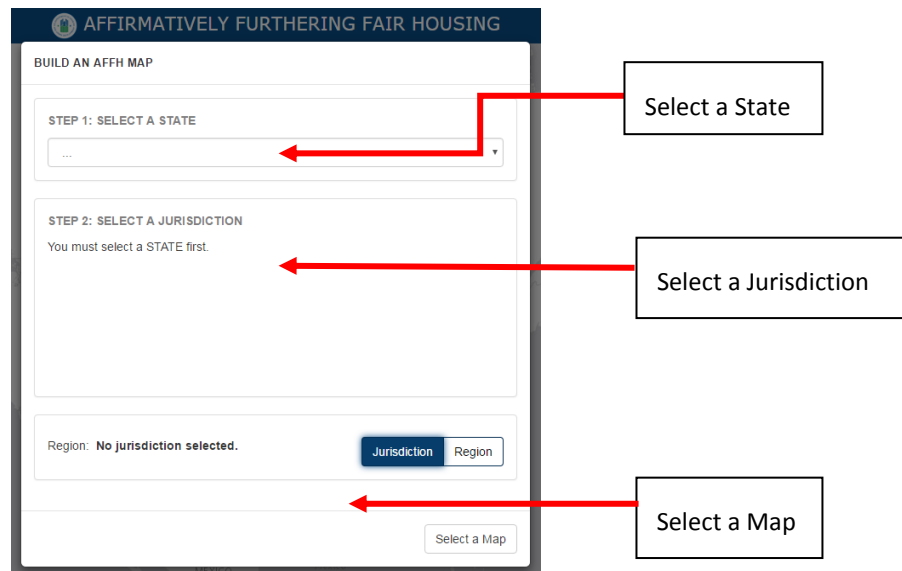

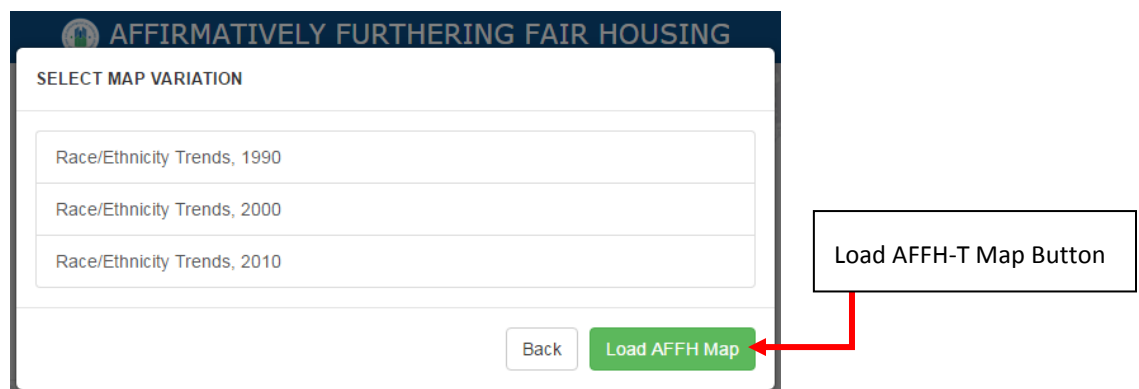

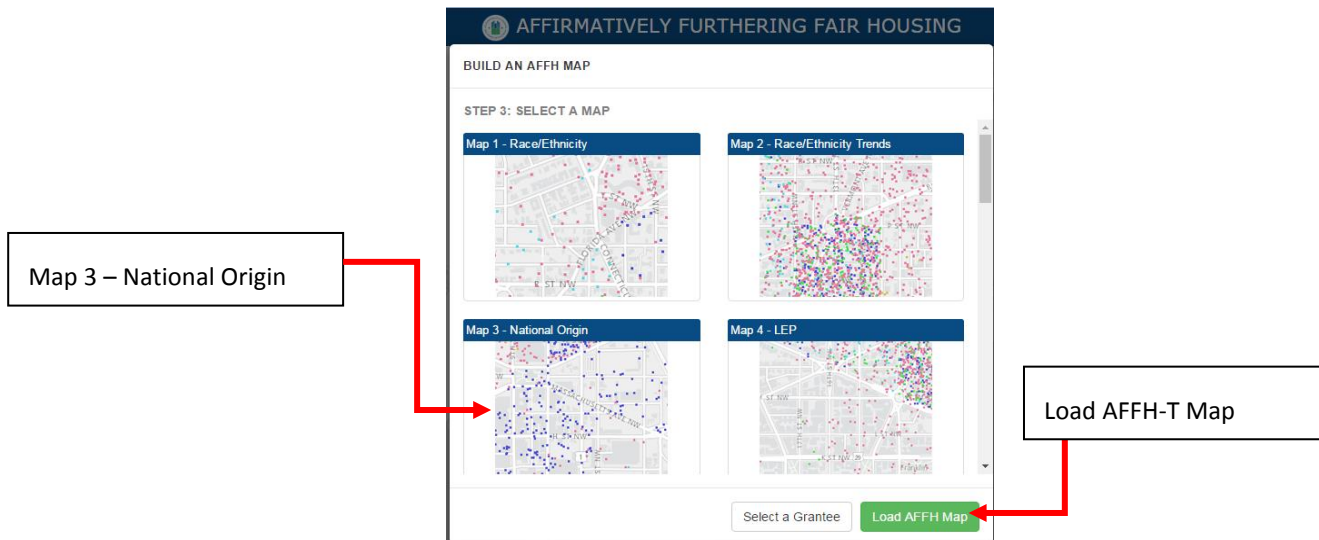

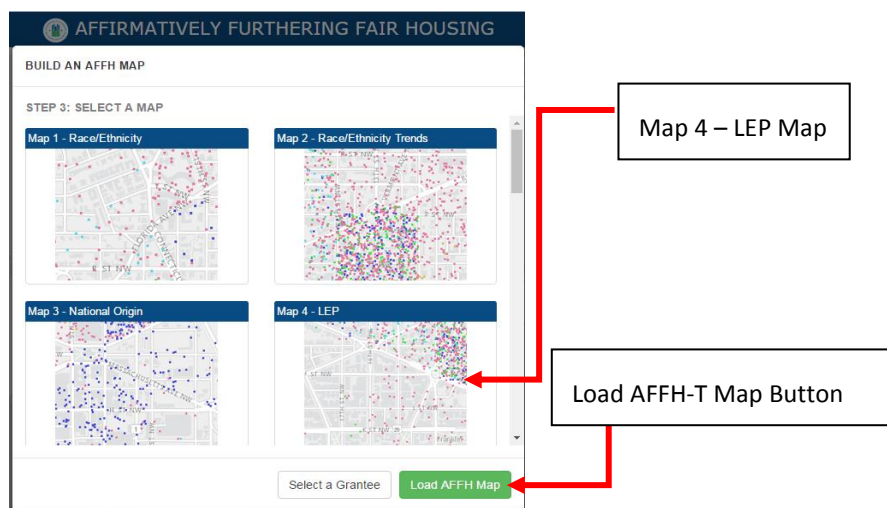

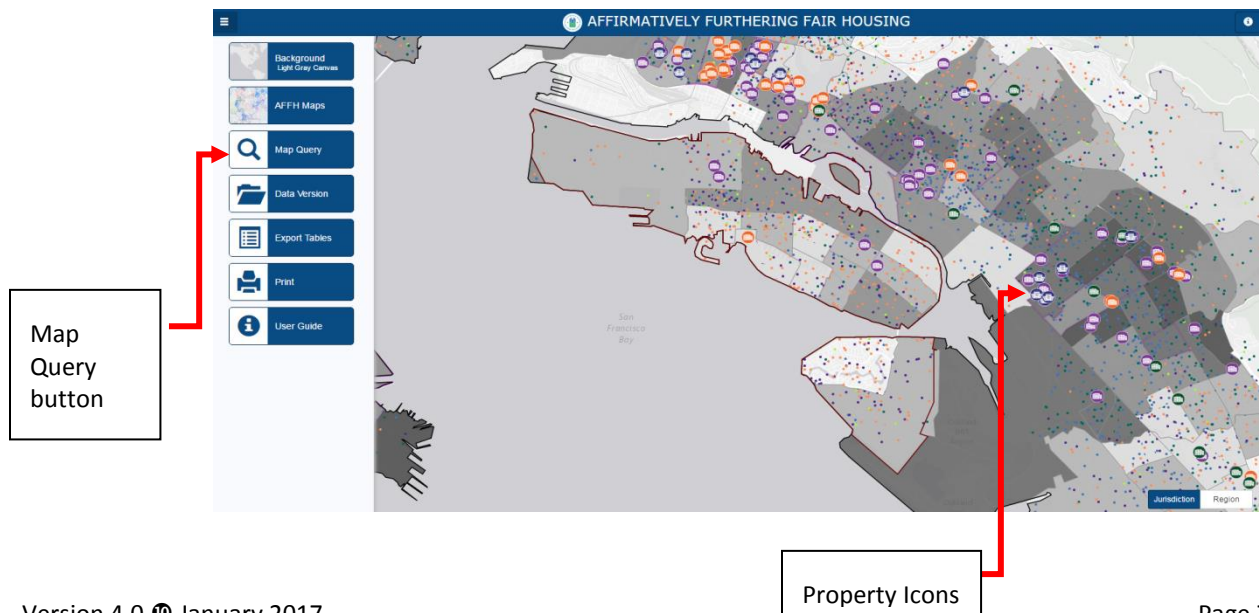

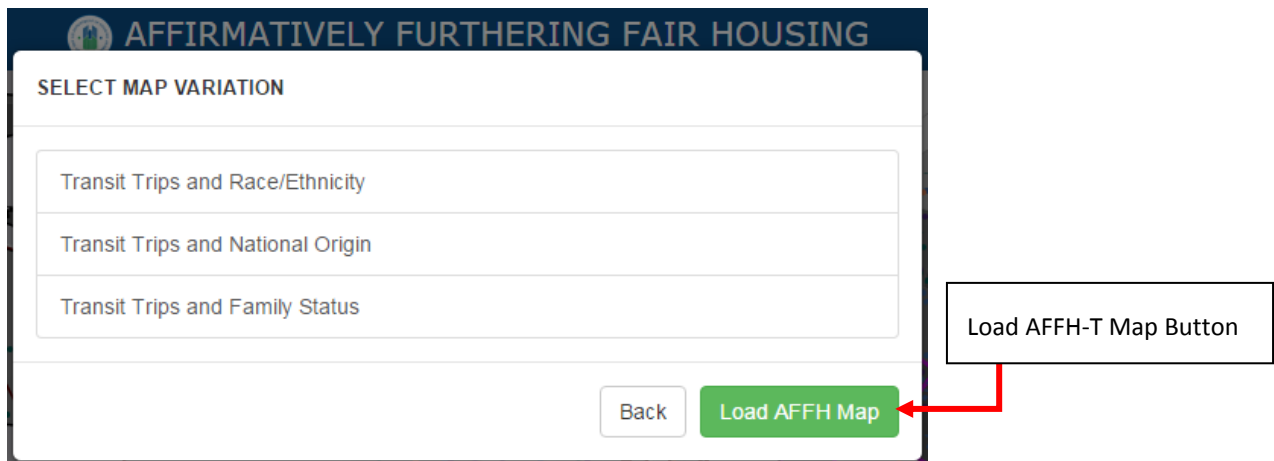

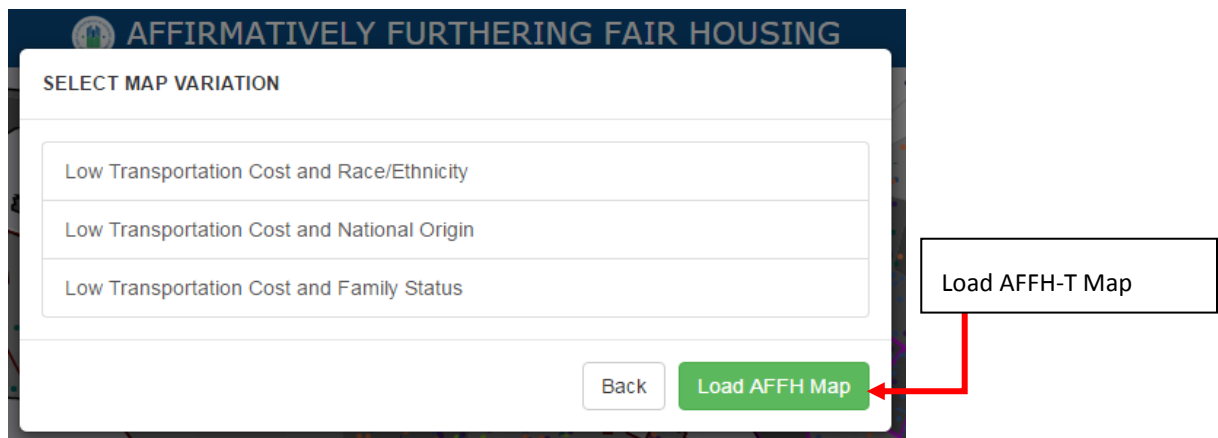

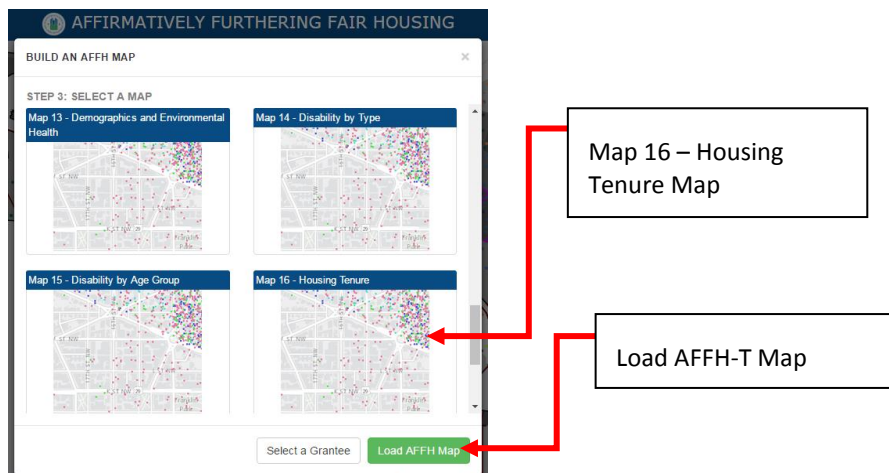

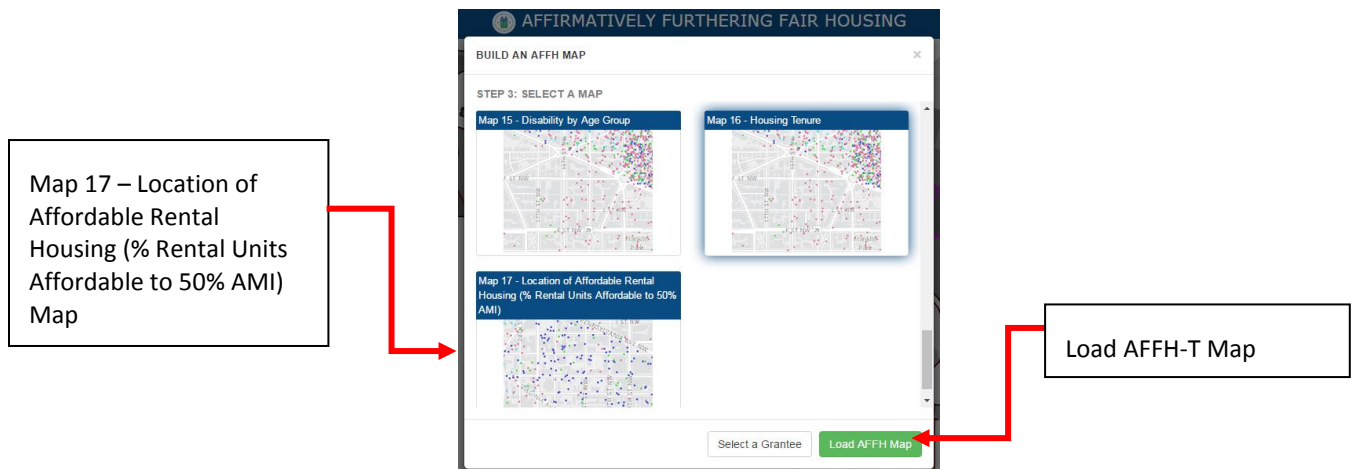

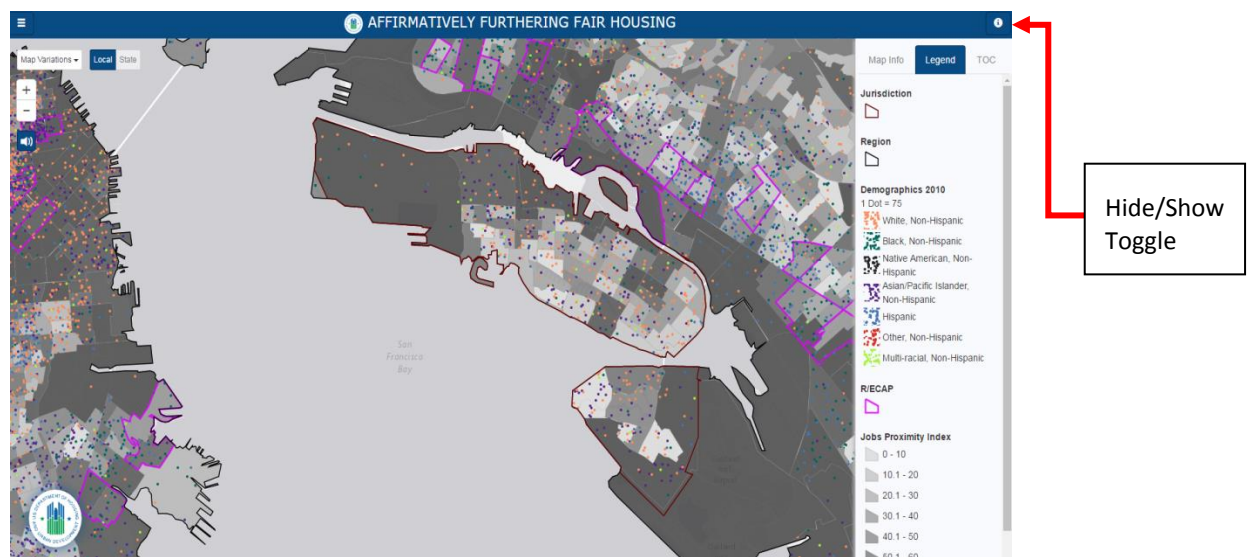
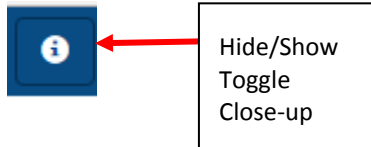

## 2.21 Map Information

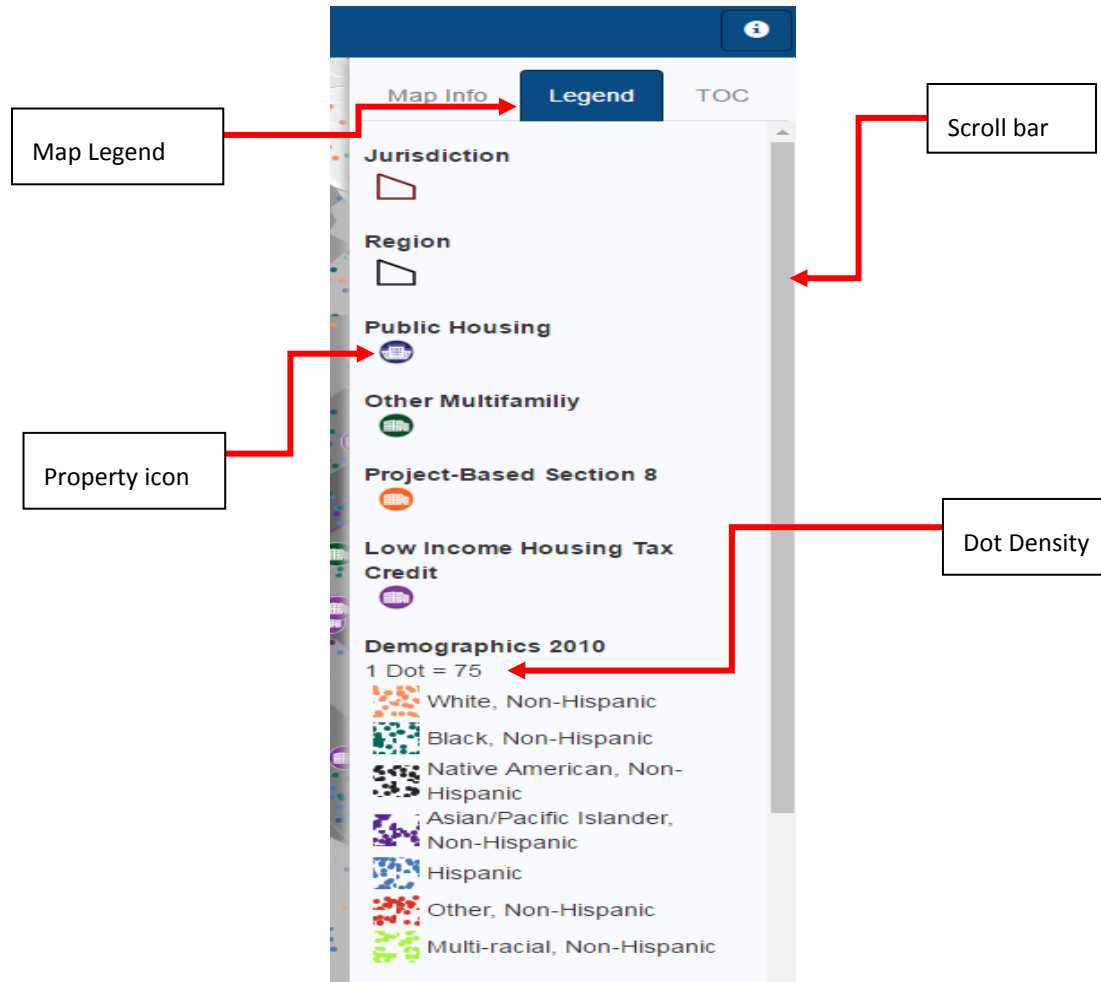


The Map Information box provides the user with detailed information as to what information they are currently viewing. This information might include:

The Legend indicates the symbolism, classifications, and color for each selected map layer.



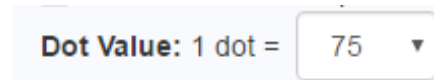
## 2.23 Map Layers - Table of Contents

The Table of Contents lists every layer on the map to show what the features in each layer represent.

## 2.24 Dot Density Renderer

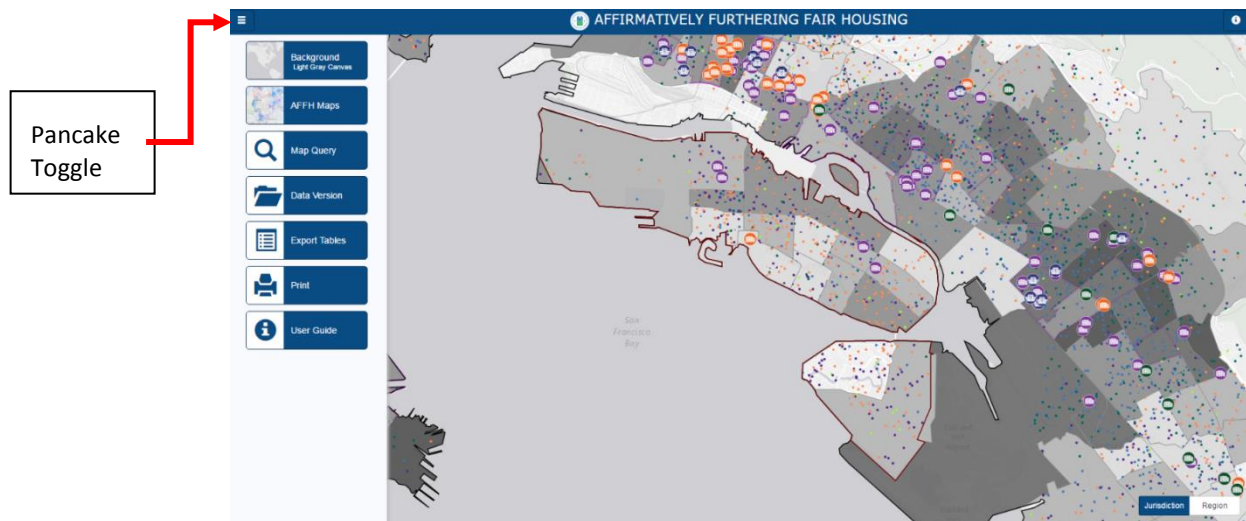
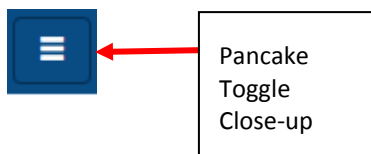


The Dot Density Renderer included in the TOC (Table of Contents) allows for the creation of dot density visualizations on data. Users can use dot density maps to visualize the variation in spatial density of a discrete spatial phenomenon. The Dot Density Renderer is adjusted via a drop-down menu that allows the user to choose one value from a list. When the drop-down list is inactive, it displays a single value. When activated, it displays a list of values in a drop-down menu, from which the user may select one. The Dot Density Renderer can be adjusted in increments of 5, starting at 1 and ending at 100. By default, the Dot Density Renderer is set to 75.

**Note: Dots are plotted randomly within tracts or block groups and do not represent actual locations.**

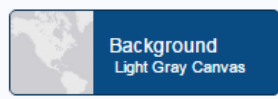
## 2.25 Hide/Show Application Tabs

Users can hide or display the application tabs by clicking the pancake on the left side of the AFFH-T top bar as shown below. When clicked, the Information area appears. When clicked again, the Information area disappears.



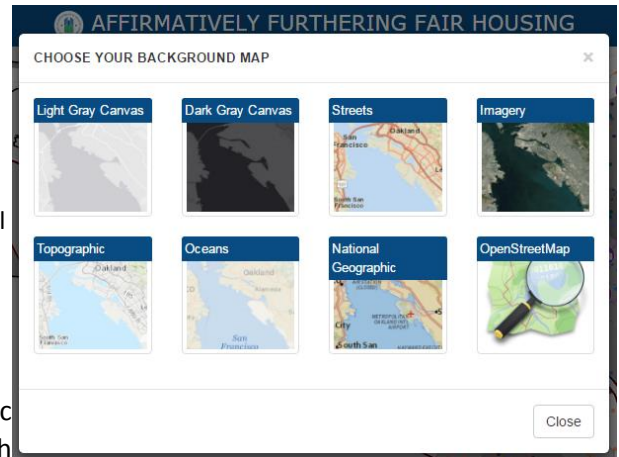


## 2.26 Specify Background Button



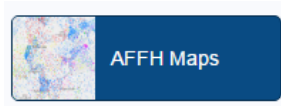
By clicking the Background button, users can specify one of 8 detail levels for a displayed map background:

- **Light Gray Canvas** – Draws attention to thematic content by providing a neutral background with minimal colors, labels, and features
- **Dark Gray Canvas** – Draws attention to thematic content by providing a dark background with minimal colors, labels, and features
- **Streets** – Presents highway-level data for world and street-level data
- **Imagery** – Displays imagery plus layers showing boundaries, places, and transportation, including street names
- **Topographic** – Displays topographic maps, which include boundaries, cities, water features, physiographic features, parks, landmarks, transportation, and buildings
- **Oceans** – Displays as a basemap that includes bathymetry, surface and subsurface feature names, and derived depths. This map is designed to be used as a basemap by marine GIS professionals and as a reference map by users interested in ocean data.
- **National Geographic** – Displays as a general reference map for information and educational purposes. This map is also designed to be used as a basemap by GIS professionals and other users for creating Web maps and Web mapping applications
- **OpenStreetMap** – Displays a map based upon a collaborative project that creates a free, editable map of the world

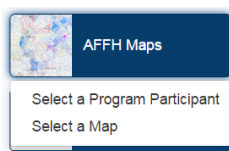




## 2.27 AFFH-T Maps Button

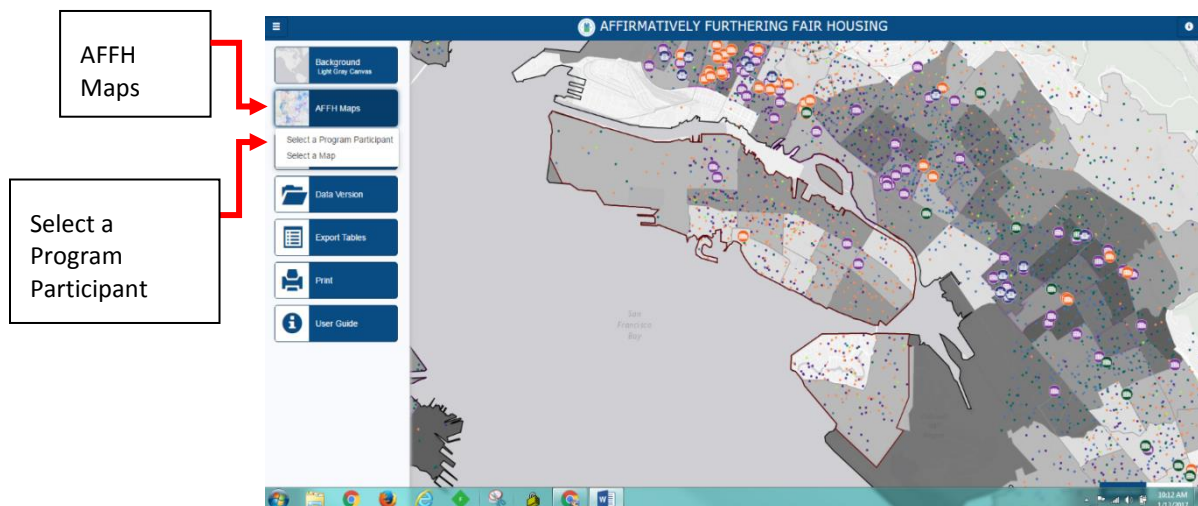


By clicking the AFFH Maps tab, users can select one of 17 maps. The drop-down menu on this button not only allows you to select a map, but also to change grantee (Program Participant). Choose “Select a Program Participant” to choose State and Jurisdiction, and choose “Select a Map” to navigate directly to the Select a Map screen.



## 2.28 Select a Grantee (Program Participant)

The Select a Grantee (Program Participant) screen, as shown below, is the landing page for AFFH-T. It allows users to view the list of Grantees by State and Jurisdiction from the drop-down menus. You can return to the Select a Program Participant screen from any screen within AFFH-T by selecting the AFFH-T Maps button and clicking “Select a Program Participant” in the dropdown.

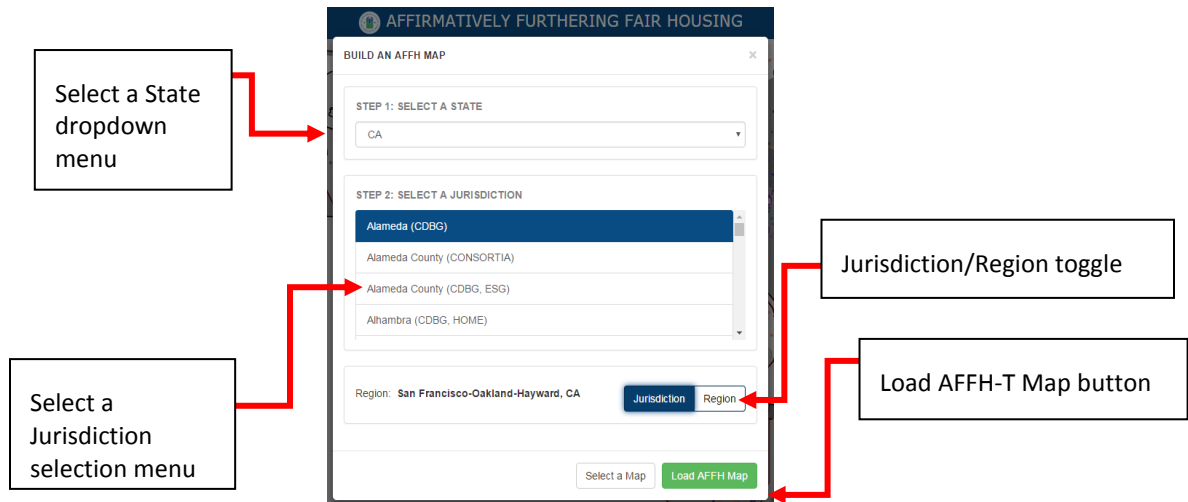




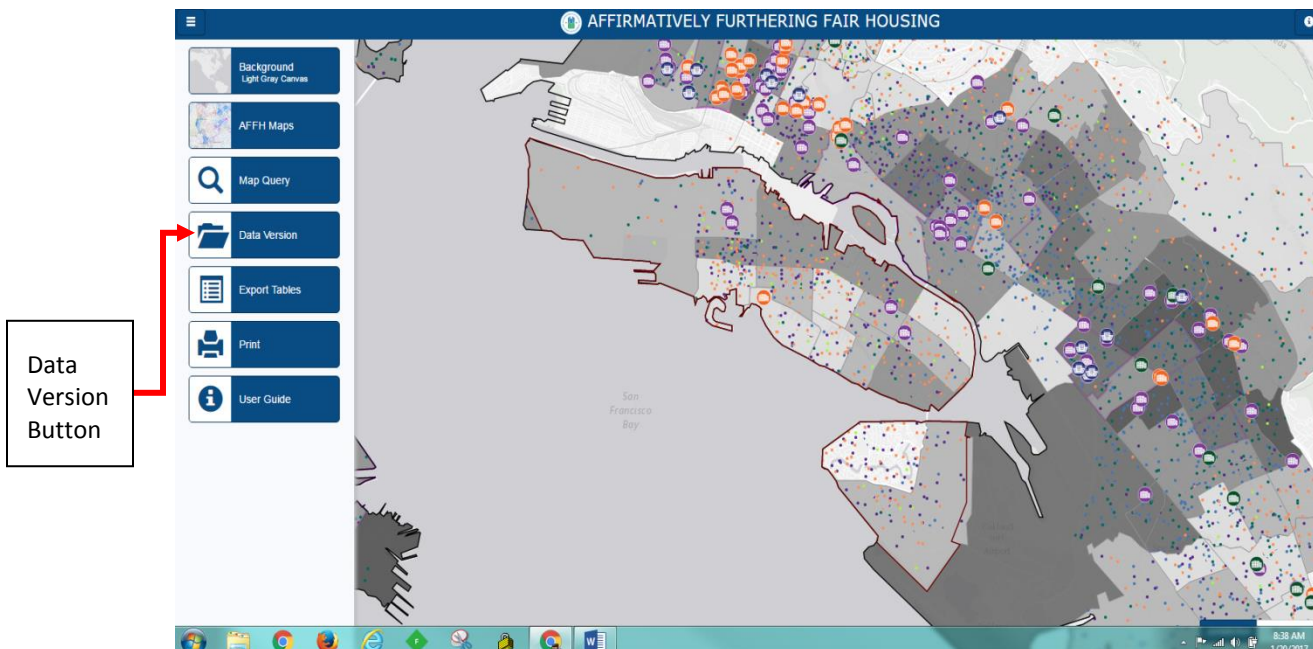


As shown below the following options are presented to users:

The Data Version Button allows the user to select previous data versions. When a user uses the AFFH-T, by default the maps and tables in the AFFH-T are created using the most recent data available. However, if a user wants to access maps and tables using the previous data versions, they can do so with the Data Version Button. It is accessed by clicking on the pancake on the top left of the AFFH-T top bar (Sec. 2.25) to open the applications tabs. The user also has the option to access more information by clicking on the hyperlink in the description portion of the window and is labeled “HUD Exchange AFFH page”.

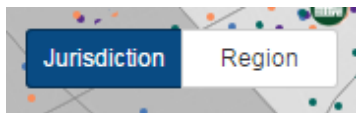

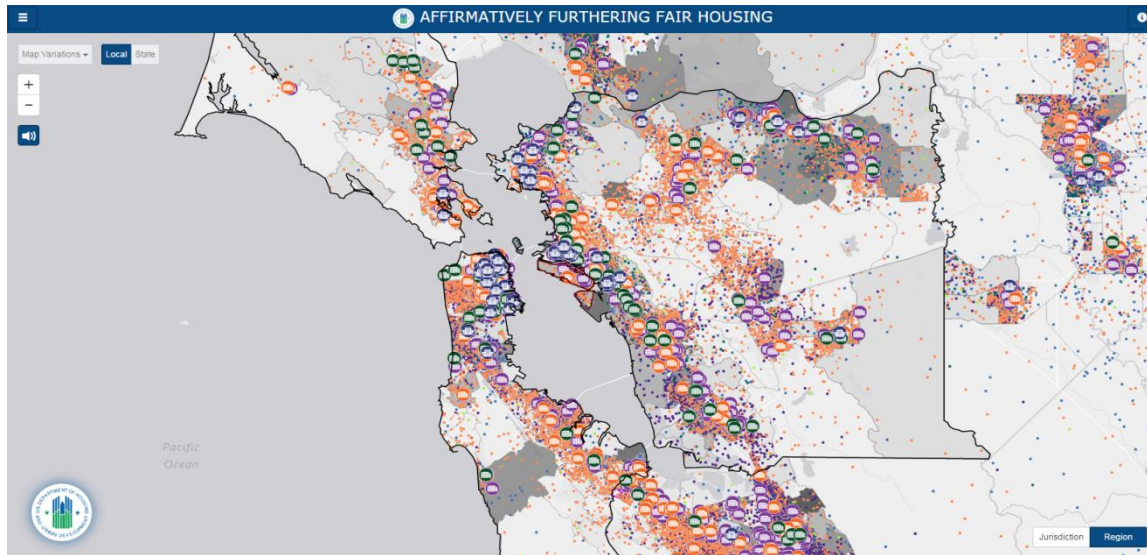
### 2.30 Toggle Jurisdiction/Region Button



The Toggle Jurisdiction/Region button is located in the lower right side of the screen and allows users to switch back and forth between two alternate views on the screen: regional view and jurisdictional view. Users should note that the Toggle Jurisdiction/Region button will not be displayed at the same time the Information area is displayed. Users will need to hide the Information area in order to access the Toggle Jurisdiction/Region button. Section 2.20 above provides instructions on how to hide or display the Information area.

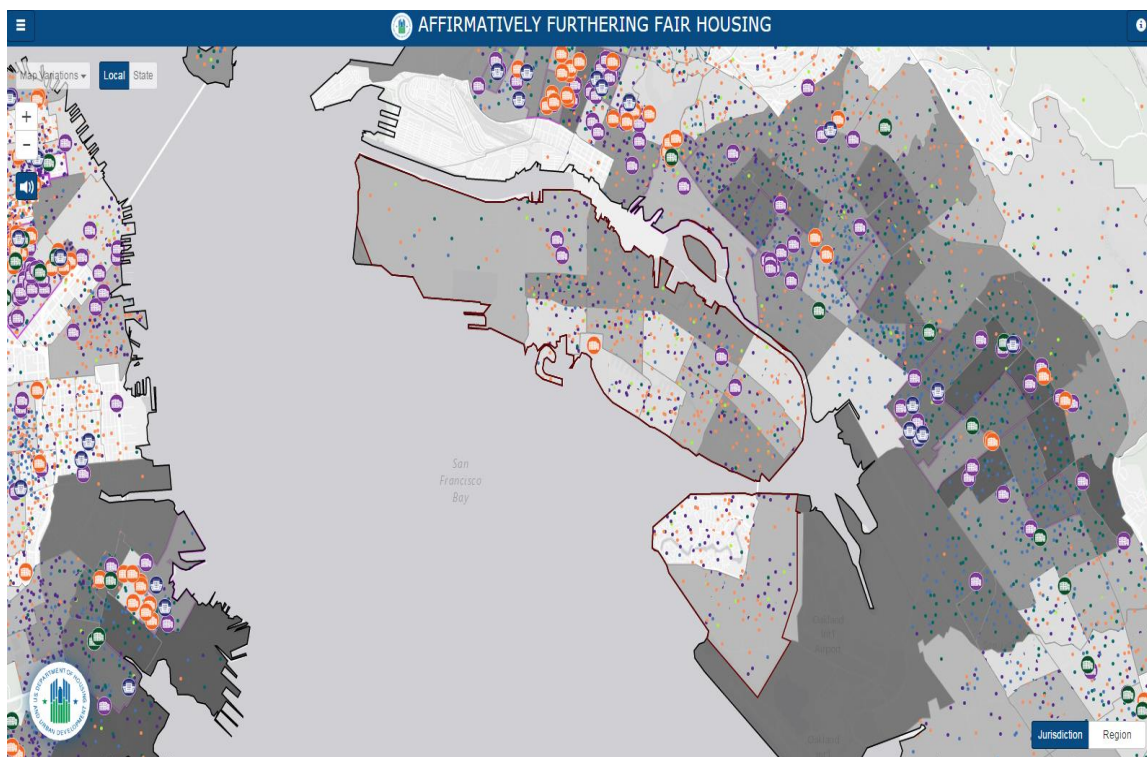

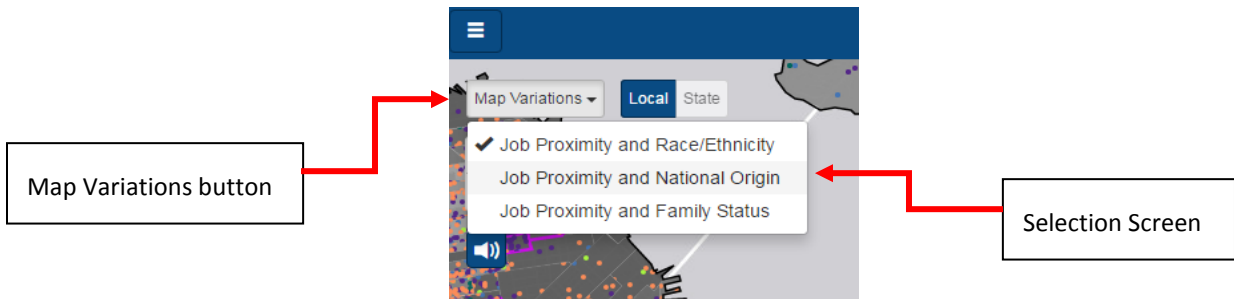

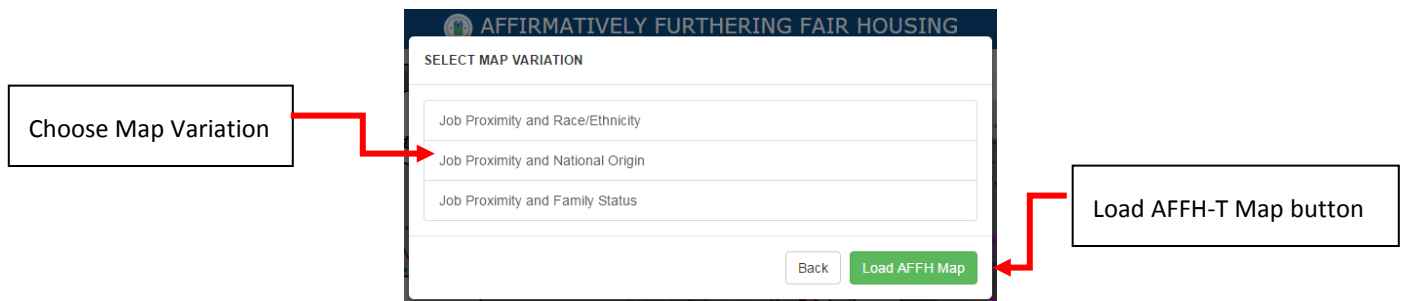
### 2.31 Map Variations Button

The *Map Variations* button is located below the pancake on the top left side of the map and allows users to choose amongst variations of the selected map when available. Utilize the dropdown arrow on the Map Variations button to open the selection screen.



### 2.32 Select Map Variation (not applicable to all maps)

The Select Map Variation pop-up window allows users to choose amongst variations of the selected map. Select the correct map variation that is appropriate, then select Load AFFH-T Map. This feature is available when the user first chooses a map or when the AFFH-T Maps button (see 2.25) is utilized.



### 2.33 Thematic Maps (not applicable to all maps)

In some of the thematic maps in the AFFH-T, the class breaks and range of values in the map reflect natural breaks based on regional-level data.

Natural breaks classes are based on natural groupings inherent in the data. Class breaks that best group similar values and that maximize the differences between classes are identified. The features are divided into classes whose boundaries are set where there are relatively big differences in the data values. Natural breaks classification is best used for mapping data values that are not evenly distributed, but instead tend to cluster into groups as natural breaks places clustered values in the same class.<sup>1</sup>





The Export Tables button allows the user to access reports and opens the Generate Table pop-up.

The Generate Table pop-up allows users to choose amongst 16 different tables and export the results to an Excel file. You can choose one table from which to export files, or you can select All Tables to see information from every table.

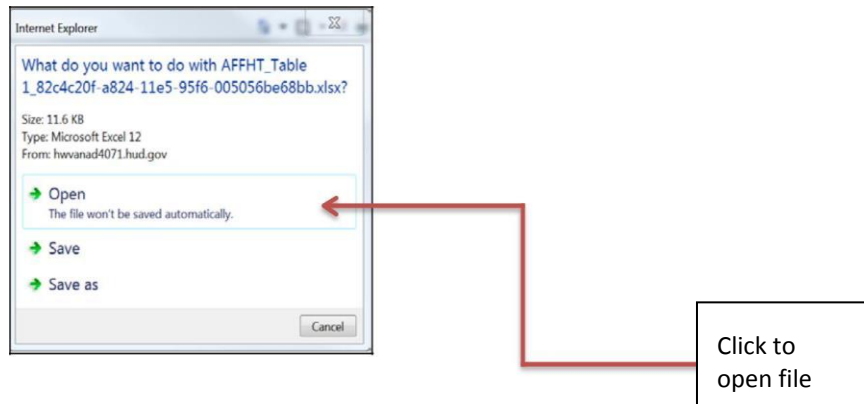


After you click the Generate Table Export button  , the user will get a “Generating Table File...” message until the Download Table File clickable link  appears when the Excel file is ready to download.

The popup will close. You may then close the Excel file and go back to the Generate Table popup.

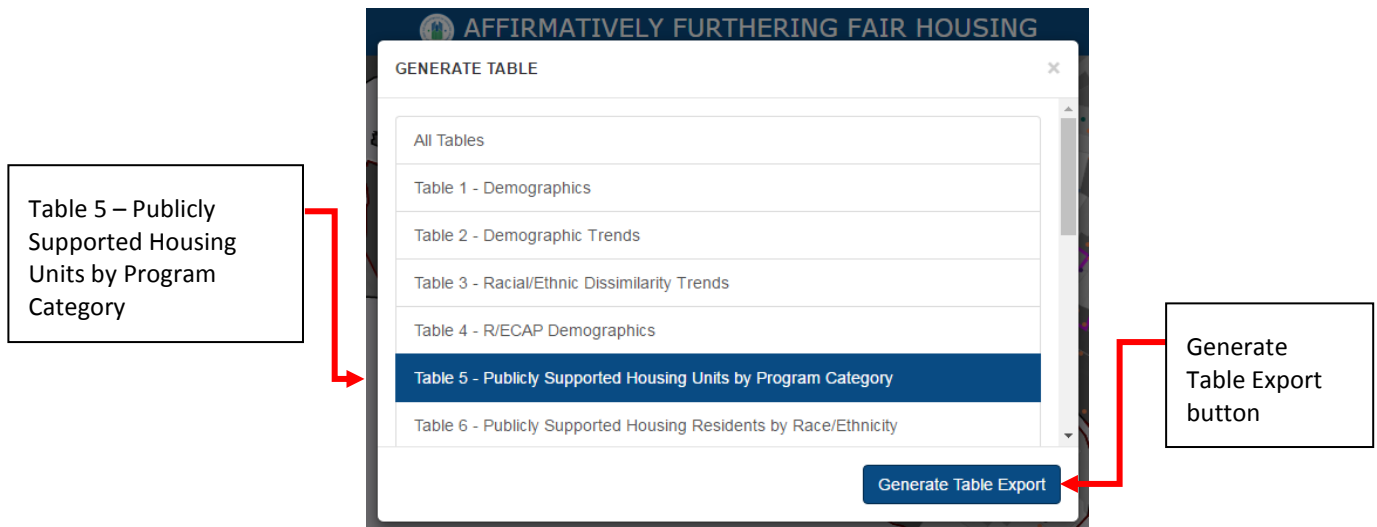

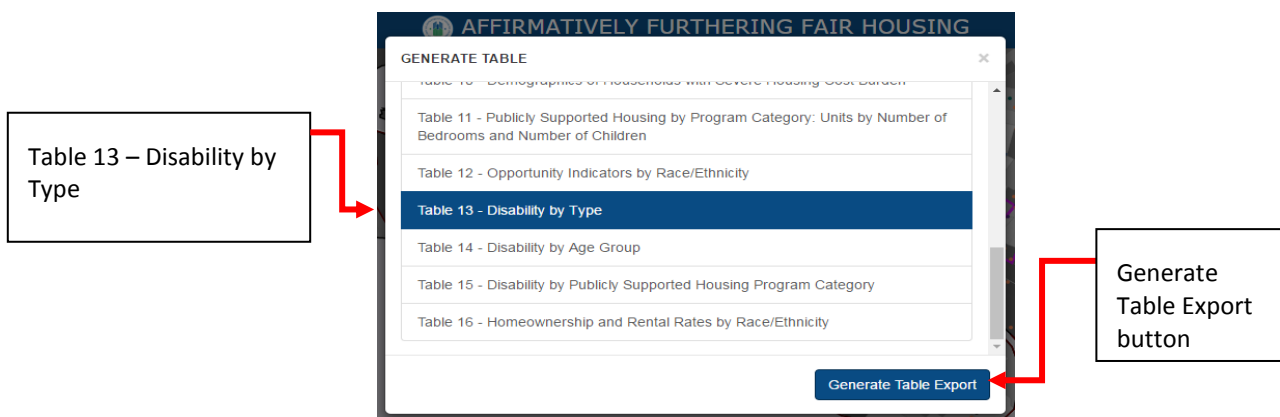

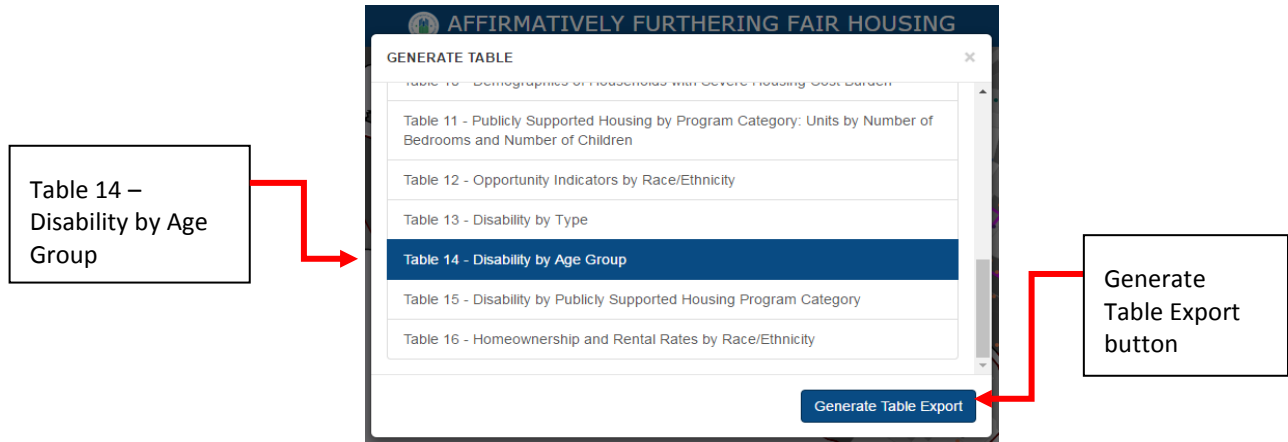
